THIS REPORT SHOULD BE FILED AS SOON AS POSSIBLE AFTER JULY 1, BUT NO LATER THAN OCTOBER 1.

Dog Taxes

WV Code 19-20-2 states that it is the duty of the Assessor to collect a head tax on all dogs 6 months of age or older. **The fee is \$3.00 per dog. Inside the city limits of Huntington it is \$4.00 per dog.** A \$10.00 kennel license covers up to 5 dogs, and each additional dog is \$3.00. **Make checks payable to the Wayne County Assessor.** See Schedule 9 on back to list dogs.
